

Talon.One INCENTIVIZE Summit Trip to London Giveaway Terms & Conditions

1. Organizer

This giveaway ("**Giveaway**") is organized by Talon.One GmbH, located at Wiener Straße 10, 10999 Berlin, Germany ("**Organizer**").

2. Eligibility

The Giveaway is open to individuals who are natural persons and, at the time of entry, satisfy all of the following conditions:

- are of legal age (at least 18),
- have unrestricted legal capacity,
- are legal residents of, and ordinarily resident in, one of the following countries: Germany, the Netherlands, or the United Kingdom,
- have taken all of the qualifying actions described in Section 3 during the Giveaway Period, and
- agree to these Terms & Conditions in full.

Employees, personnel, service providers of the Organizer, their immediate families, and any third parties directly associated with the administration of the Giveaway are not eligible to participate (the time of the prize drawing is decisive).

3. Entry Requirements

To enter the Giveaway, participants must:

- Scan the QR code and (or otherwise) access the online registration form to which the QR code leads;
- Truthfully complete the online registration form with the following information: full name, email address, job title, and company name; and
- Agree to these T&C during the registration process on the following webpage: <https://www.talon.one/download/creative-currencies-in-promotions-competition>

Only one entry per person is allowed. Multiple entries will be disqualified. No payment or purchase is required or implied in order to enter.

4. Exclusion from participation

The Organizer will exclude participants which have not truthfully completed the online registration form and/or which manipulate(d) or attempt(ed) to manipulate the participation and/or registration process, the drawing and/or otherwise violate the conditions of participation. The Organizer can also exclude participants retrospectively and reclaim the prize in such case at the excluded participant's costs.

5. Prize

The prize consists of:

- Hotel: One hotel room for up to two people at St. Pancras Renaissance Hotel London OR a similar hotel located in London, England selected by the Organizer,

subject to availability, with check-in on November 3, 2026 and check-out on November 5, 2026. Specific room types cannot be guaranteed.

- Airline Voucher: One (1) airline voucher with a value of €400 (four hundred euros), redeemable with an airline of the winner's choice that offers purchasable vouchers ("Eligible Airline"). The Organizer will provide the voucher via direct purchase of voucher on winner's behalf or electronic gift card. The winner is solely responsible for selecting an Eligible Airline and for all travel bookings, additional costs, and compliance with the airline's own terms and conditions.

6. Prize Conditions and Exclusions

- The prize is non-transferable, non-negotiable, and cannot be exchanged for cash or any alternative.
- The Organizer reserves the right to substitute the prize (or any element thereof) with an alternative of equal or greater value, at its sole discretion, if circumstances beyond its control make the original prize unavailable.
- Hotel accommodation is subject to availability at the time of booking. Specific room types cannot be guaranteed.
- The airline voucher is valued at €400. Currency conversion, if applicable, will be calculated at the prevailing rate at the time of transfer. The Organizer is not responsible for exchange rate fluctuations.
- Except for the airline voucher and hotel accommodation, the winner is responsible for all travel costs, including but not limited to all meals, personal spending, additional room charges, travel insurance, and any other costs not expressly stated as included in the prize.
- The prize winner is encouraged to attend the INCENTIVIZE Summit in London on November 4, 2026. If the Event is cancelled or materially changed by the Organizer, the Organizer may shift the prize to the new dates.
- The winner is responsible for possessing valid travel documentation (e.g. must hold a valid passport and any required visa or travel documents). The Organizer has no obligation to assist with visa applications and accepts no liability for any visa or border control refusal.
- Any tax liability arising from receipt of the prize is the sole responsibility of the winner.

7. Prize Value

The approximate total retail value ("ARV") of the prize is €1,800–€2,400 depending on hotel. The ARV is provided for information only and does not affect the prize awarded.

8. Winner Drawing and Notification

The Organizer will draw the winner randomly from all eligible participants. The winner will be notified via the email address provided in the entry form within two weeks of the Giveaway's closing date. If the winning participant does not respond within 7 calendar days of the initial contact, the Organizer is entitled select an alternative participant as winner.

To claim the prize, the winner must:

- Confirm acceptance of the prize and these T&Cs in writing;
- Provide proof of eligibility (including proof of age and proof of residence in an eligible country) within the timeframe specified by the Organiser;
- Return a completed and signed Winner Declaration Form within the deadline specified.

9. Giveaway Period

The Giveaway will run from 16.04.2026 to 30.05.2026. Entries received outside this period will not be considered. The Organizer's records shall be conclusive as to the time of receipt of entries.

10. Data Protection

If the participant enters the Giveaway, Talon.One GmbH will process the personal data (name, email address, job title, company name) of the participant for the purposes of administering the Giveaway and contacting the winner. If the participant has provided consent to process the personal data for advertising purposes, Talon.One GmbH processes the data as stipulated in the consent form. 11. Termination and Amendments, Decisions of the Organizer

The Organizer is entitled to cancel, terminate, modify, or suspend the Giveaway in the event of unforeseen circumstances beyond its control or if, for technical or other reasons, proper conduct of the Giveaway cannot be guaranteed or the fairness of the Giveaway appears to be compromised. The Organizer's decisions regarding any aspect of the Giveaway are final and binding, and no correspondence will be entered into. This does not give rise to claims for the participants.

12. Liability

The Organizer is only liable for intent and gross negligence. This does not apply in the case of a negligent breach of an essential contractual obligation. These are obligations that are essential for the execution of the Giveaway, as they make the Giveaway possible in the first place, and the fulfillment of which the participant therefore relies on and may rely on. In this case, the Organizer's liability for simple negligence is limited to foreseeable damage typical for the present Giveaway. The limitation of liability does not apply to damages resulting from injury to life, limb or health.

13. Governing Law

The Giveaway and these Terms & Conditions are governed by the laws of the Federal Republic of Germany under the exclusion of the conflict of law rules and the UN Sales Law. Any disputes will be subject to the exclusive jurisdiction of the courts of Berlin, Germany.
